MEMORANDUM OF UNDERSTANDING (MoU)

Between Tunga Mahavidyalaya And Finnmantra (Represented by CEO – Mr. Anoop Gowda)

This Memorandum of Understanding ("MoU") is executed on this 16th day of JULY 2025 at

1. Parties

1. **Tunga Mahavidyalaya**, having its principal place of business at THIRTHAHALLI, hereinafter referred to as "the College", represented by its authorized signatory.
2. **Finn mantra**, a financial education and advisory firm, having its office at THIRTHAHALLI, hereinafter referred to as "the Partner", represented by its Chief Executive Officer **Mr. Anoop L U**.

The College and the Partner are hereinafter collectively referred to as "Parties" and individually as a "Party".

2. Objective

The objective of this MoU is to establish a collaborative association between the College and Finn mantra for conducting financial awareness programs, seminars, professional orientation sessions, and value addition courses for:

- a) Students
- b) Teaching faculty
- c) CA, CS and other professional aspirants associated with the College

3. Scope of Work

a) Finn mantra shall conduct a minimum of two (2) programs per year at Tunga Mahavidyalaya during the contract period.

b) The programs may include but are not limited to:

- Personal finance awareness
- Investment and wealth-building basics
- Tax planning and financial literacy
- Career guidance in finance, CA, CS, CMA, and related fields
- Professional skill development sessions for students and faculty

c) Finn mantra may also conduct orientation programs for newly admitted students and professional course aspirants as required.

d) Any programs or services beyond the minimum commitment shall be considered as **additional work**, for which **nominal additional charges** shall be mutually discussed and finalized separately before commencement.

4. Duration

This MoU shall be valid for a period of **three (3) years** starting from the date of signing, unless terminated earlier by mutual consent or as per the termination clause mentioned below.

5. Roles and Responsibilities

5.1 Responsibilities of Finn mantra (Mr. Anoop L U)

- To design and deliver structured financial awareness and education programs.
- To provide qualified resource persons for training and seminars.
- To share presentation materials and learning resources as required for academic purposes.
- To maintain the quality and relevance of content as per current financial and professional standards.

5.2 Responsibilities of Tunga Mahavidyalaya

- To provide venue, basic infrastructure, and logistical support for conducting the programs.
 - To ensure participation of students, faculty, and professionals.
 - To coordinate scheduling and communication between Finn mantra and participants.
 - To promote the programs within the institution.

6. Financial Terms

- The two minimum programs per year shall be conducted as per mutually agreed financial terms.
 - Any additional sessions, workshops, or customized programs requested by the College shall be charged separately based on program type, duration, and resource requirements.
 - Payment terms, including timeline and mode, shall be mutually agreed upon for each event.

7. Intellectual Property

All training materials, modules, and content created by Finn mantra shall remain the intellectual property of Finn mantra.

The College may use such materials strictly for internal academic and non-commercial purposes, with due credit given to Finn mantra.

8. Confidentiality

Both Parties agree to maintain confidentiality of any sensitive or proprietary information shared during the course of this association and shall not disclose such information to third parties without prior written consent.

9. Termination

Either Party may terminate this MoU by giving 30 days written notice to the other Party, stating valid reasons for termination.

Any ongoing program at the time of termination shall be mutually settled.
